HISTORICAL NOTE

In 1969, the U.S. Department of Health, Education, and Welfare (HEW) notified ten states, among them Louisiana, that they were maintaining a racially-based dual system of higher education in violation of the Fourteenth Amendment of the U.S. Constitution and the Civil Rights Act of 1964. HEW required all ten states to submit plans for desegregation of their higher education systems and threatened any state's noncompliance with termination of federal funds. Louisiana refused to provide plans for desegregation on the grounds that their open admissions policy was already in compliance with Title VI.

In 1974, the U.S. Justice Department filed suit against Louisiana and its boards of higher education after contending that Louisiana's open admissions policy was not in compliance with federal law. After initial discovery proceedings, however, the suit lay dormant until it was reactivated in 1979. In 1981, just before the case went to trial, the two parties agreed to a court-approved Consent Decree.

In the Consent Decree, Louisiana agreed to seek to improve racial diversity at its public institutions of higher education through detailed recruitment plans for students, staff, and faculty; to enhance programs, facilities, and faculty at historically black institutions; to distribute desirable degree programs equitably; and to institute cooperative programs and activities between historically black and white universities. The two parties agreed that this Consent Decree would be in effect for six years, at which time progress toward the elimination of the dual system of universities would be reevaluated.

A committee dedicated to monitoring the execution of the Consent Decree was formed, which collected data and documentation of efforts by state universities to comply. This committee created reports and files on the efforts by each campus to institute the guidelines established by the court.

In 1987, just before the expiration of the Consent Decree, the Department of Justice moved that Louisiana had not fulfilled its obligations under the Consent Decree and in 1988, after legal maneuvering on both sides, the court ruled that Louisiana was still in violation of Title VI and that the Consent Decree had not been effective. Louisiana was asked to submit a remedial plan for desegregation. When the two parties to the suit were unable to agree on a plan, the court appointed a Special Master who was charged with recommending a desegregation plan. In 1989, the court recommended the plan formulated by the Special Master. Under this plan, the state's multiple boards of higher education would be combined into one, the law schools at Southern University and Louisiana State University would be combined, and all institutions would be differentiated by admissions standards. Between 1988 and 1993, however, a series of remedial orders were vacated after extended litigation.

Finally in 1994, all parties to the lawsuit reached a Settlement Agreement. This ten-year agreement included the establishment of an open-admissions community college in Baton Rouge, to be administered jointly by LSU and Southern University, which allowed LSU and SU to institute selective admissions programs. The Settlement Agreement also maintained the state's multiple boards of higher education and left in place both law schools in Baton Rouge. The plan called for spending over \$100 million during its ten year term: the money was to be spent on construction projects at Southern and Grambling, fostering doctoral programs at Southern, and recruiting black students to historically white schools and vice versa.

SCOPE AND CONTENT NOTE

This collection contains legal documents, meeting minutes, agendas, correspondence, reports, and printed materials associated with the lawsuit against the state of Louisiana by the U.S. Department of Justice and the resulting Consent Decree. Included are legal documents from the lawsuit itself and meeting minutes and agendas of various committees associated with the Consent Decree. Correspondence includes letters between administrators, board members, and lawyers and letters from community members to university administrators regarding desegregation. Notable items include letters from Troy Middleton regarding LSU and integration, documents related to the fight for a doctoral program in computer science between various campuses in the LSU System, and an extensive collection of newspaper articles from local and regional papers regarding affirmative action and desegregation. Printed materials comprise student recruitment materials, maps, brochures, and newspaper articles covering the process of desegregation. Reports include proposals for new programs in the LSU system, reports on the status of the consent decree, and data on admissions, employment, enrollment, grades, and graduation rates for the LSU system.

Subgroup 1. Office of Academic Affairs Records: Consent Decree.

Reports, correspondence, drafts, and proposals for academic planning documents generated by the campuses in the LSU system.

Affirmative action plans from campuses in the LSU system, with related correspondence, reports, and newspaper articles.

Series III. Compliance, 1958-1989; undated.

Documentation of the LSU system's attempts to comply with the terms of the Consent Decree. Included in this series are annual reports from the campuses; meeting minutes and correspondence; records of the Clearinghouse for Black Faculty and Professional Staff; documents from cooperative efforts between the LSU campuses and the Southern University campuses; records from fellowship programs; student recruitment efforts; reports from monitoring committees; data on student enrollment, attrition, graduation, and grades; and newspaper articles showing public perception of events related to the consent decree.

Series IV. Consent Decree Background Files, 1947-1973; undated.

Documents that precede the era of the Consent Decree, including legal documents, newspaper articles, college applications submitted to LSU by African Americans, and personal correspondence among LSU administrators. Notable items include: rejection letters sent to African American applicants; letters to LSU administrators from concerned community members (both against and in favor of desegregation); correspondence regarding African American participation in LSU athletics; personal correspondence of Troy Middleton regarding desegregation and its implications for LSU.

Paperwork produced in the process of monitoring the progress of the consent decree. Included are correspondence, meeting minutes, agendas, and reports. Also included are reports submitted by different governing boards to the Committee for their quarterly meetings during the six years of the consent decree.
